RESOLUTION PROHIBITING THE USE OF THE PNP PATROL CAR FOR PURPOSES OTHER THAN THE PURSUIT OF POLICE OPERATION AND EMERGENCY.

WHEREAS, the Philippine National Police patrol car is intended for its military operations and emergencies in the interest of public security;

WHEREAS, it has been the observation of the Body that the patrol car is sometimes used for purposes other than what it is intended for;

NOW THEREFORE, on motion of Kgd. Eriberto Seria, Jr. which is seconded by Kgd. Alfredo Cabanilla, the Body RESOLVED, as it is hereby RESOLVED to prohibit the use of the PNP patrol car if there is no military operation and emergency to make it visible and ready at all times at the PNP Headquarters;

RESOLVED FURTHER that a copy of this resolution be furnished to Capt. Maximo Terricer, Chief of Police, for his information, compliance and implementation.
