

ORDINANCE NO. 2-09 Series of 1993

ORDINANCE PROHIBITING LITTERING AT PUBLIC PREMISES AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.

Be it enacted by the Sangguniang Bayan of Narvacan in session assembled:

Section 1. <u>Tittle.</u> This Ordinance shall be known as "The Municipal Anti-Littering Ordinance".

Section 2. Definition of Terms. Public Premises include all places which are owned by the government and usually frequented by the general public such as sidewalks, streets, roads, plaza, parks, markets and government buildings.

Section 3. Prohibitions. It shall be unlawful:

- a. For any person to throw or dispose of garbage, trash, pieces of papers, cigarette butts, woppers, ppuplings and any kind of waste materials on the sidewalks, streets, roads, plaza, parks, markets, government buildings and on amy other public places except inside garbage or trash cans, boxes or containers intended thereof;
- b. For any person to scatter the garbage or trash cans, boxes or containers;
- c. For any person to urinate or discharge human waste in a public place of public view, such as but not limited to streets or public markets, other than in places designated o therefor.

Section 4. Penal Provisions. 1. Any person or persons found violating the provisions of paragraph a b, and c of Section 3 shall be meted the following penalties to wit:

- a. For the first offense, twenty five pesos (\$25.00) or imprisonment of three days, or both such fine and imprisonment in the discretion of the court.
- b. For the second and succeeding offenses, for each offense a fine with fifty pesos (\$750.00) or imprisonment of six (6). days, or both such fine and imprisonment in the discretion of the court.
- In case of the offender is over twelve (12) years of age but below of fifteen (15) years of age, the penalties shall be:
 - a. For the first offense, one half (1/2) of the penalties imposed for adults or one and a half (11/2) days, of imprisonment on both such fine and imprisonment in the discretion of the court. In addition, the offender is subject to repremand in the presence of the parents or guardians.
 - b. For the second and succeeding offenses, for each offense a fine of fifty pesos (\$50.00) or imprisonment in the discretion of the court.

3. In case the offender is twelve years of age and below the penalty shall be left in the discretion of the court.

Section 5. Final Provision.

- a. Repealing Clause. All municipal ordinances, municipal executive orders, administrative regulations, or parts thereof which are inconsistent with any of the provisions of this ordinance are hereby repealed or amended
- b. Separability. Clause. If, for any reason or reason any part or provision of this Ordinance shall be declared unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in force and effect.
- c. Effectivity Clause. This Ordinance shall take effect
