RESOLUTION ENJOINING LAW ENFORCEMENT AGENCIES TO CAUSE THE IMMEDIATE  
STOPPING OF ALL FORMS OF ILLEGAL GAMBLING WITHIN THE LIMIT OF NARVACAN,  
ILOCOS SUR.

WHEREAS, it is of common knowledge that several forms of illegal  
gambling, including "jueteng", are being operated within the Municipa-  
lity of Narvacan, Ilocos Sur;

WHEREAS, it has been the clamor of religious groups and other  
concerned citizens in this municipality that these illegal gambling  
activities must be stopped;

WHEREAS, it is incumbent upon law enforcement agencies to strictly  
enforce anti-gambling laws;

NOW THEREFORE, the Sangguniang Bayan of Narvacan, Ilocos Sur, in  
regular session duly assembled,

RESOLVED, AS IT HEREBY RESOLVED, to enjoin all law enforcement  
agencies to cause the immediate stopping of all forms of illegal gambling  
within the limit of Narvacan, Ilocos Sur;
