RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO DONATE THE MUNICIPAL AMBULANCE TO THE MUNICIPAL OFFICE OF THE BUREAU OF FIRE PROTECTION

WHEREAS, the Local Government Unit of Narvacan, Ilocos Sur owns an old Toyota Ambulance (Model RH 18V) which was acquired in 1988;

WHEREAS, said ambulance, considering the many number of years it has served as such can now hardly run efficiently;

WHEREAS, the overhead maintenance cost of the ambulance does not well justify its present condition;

WHEREAS, there is another Philippine Charity Sweepstakes Office-donated ambulance now owned by the LGU of Narvacan which serves the municipality in emergency cases;

WHEREAS, the Municipal Office of the Bureau of Fire Protection has expressed its intention to maintain the old ambulance, providing it the necessary overhauling and repair without cost to the Municipal Administration on the condition that it be donated to this office;

WHEREAS, the members of the Municipal Council find it within reason to favor such intention as this will save the Municipal Administration on cost as subject vehicle would still serve the constituents of the municipality;

NOW THEREFORE, on motion duly seconded by the Body, BE IT RESOLVED AS IT IS HEREBY RESOLVED to authorize the Hon. Edgardo D. Zaragoza, Municipal Mayor to donate the old Toyota ambulance to the Municipal Office of the Bureau of Fire Protection;

RESOLVED FURTHER that this donation is made on condition that the old ambulance shall be for the exclusive use of the Municipal Station of the BFP and on some occasion by the Local Government Unit of Narvacan subject to provisions set forth in the Deed of Donation to be executed by the Honorable Mayor Edgardo D. Zaragoza and the Municipal Fire Marshall.

RESOLVED FINALLY that copies of this resolution be forwarded to all concerned parties for their information and appropriate action.
