RESOLUTION AMENDING ORDINANCE NO. 2-17, SERIES OF 1994 PRESCRIBING RULES AND REGULATIONS FOR THE SALES OF INTOXICATING LIQUOR AND OTHER ALCOHOLIC DRINKS AND THE PENALTIES AND FINES IMPOSED UPON VIOLATORS.

WHEREAS, the members of the Municipal Council recognize the need to maintain peace, order and tranquility in the community;

WHEREAS, one way to achieve this is to regulate the selling of liquors.

NOW THEREFORE, on motion duly seconded, BE IT RESOLVED AS IT IS HEREBY RESOLVED to amend Ordinance No. 2-17, series of 1994. Prescribing Rules and Regulations for the sales of intoxicating liquor and other alcoholic drinks and the penalties and fines imposed upon violators.

BE IT ENACTED by the Sangguniang Bayan of Narvacan in session assembled to adopt Ordinance No. 97-98-05.

## ORDINANCE NO. 97-98-05 Series of 1997

PRESCRIBING RULES AND REGULATIONS FOR THE SALES OF INTOXICATING LIQUOR AND OTHER ALCOHOLIC DRINKS AND THE PENATIES AND FINES IMPOSED UPON VIOLATORS.

Section 1, Basic Objectives

- a. It is the policy of the Municipal Administration of Narvacan for its people to enjoy genuine and meaningful orderly and peaceful community living.
- b. It is also the paramount concern and duty of the Municipal Administration to adopt and institute measures to enhance public interest whereby the people may be assured the true blessings of a harmonious society.
- c. It is likewise the aim of this municipality to establish a healthy, decent and sound environment wherein the people's welfare be promoted and safeguarded from fear, disturbance and violence from misguided and uncontrolled elements of society caused by drunkenness.

Section 2. Scope and Application -

This Ordinance shall apply to all barangays within the territorial jurisdiction of the municipality of Narvacan, Ilocos Sur.

Establishment affected by this Ordinance -All stores, restaurants, bars, carinderias or places where intoxicating liquor or wines are sold, disposed of or given away. Section 4. Implementing Clause The Office of the Municipal Mayor is hereby tasked to implement the provisions of this Ordinance and may from time to time issue rules and regulations it may deem fit and necessary for the effective implementation of this Ordinance. Section 5. Rules and Regulations a. Only stores, restaurants, bars or any business establishments duly licensed by the Office of the Mayor are permitted to sell, dispose of or give away intoxicating liquor, wine or any alcoholic drinks. b. All stores or any business establishments could any only sell, dispose of or give away in intoxicating liquor, wine or alcoholic drinks from 6:00 o'clock in the morning to 8:00 o'clock in the evening.

c. It is prohibited to drink alcoholic drinks and mubble places. intoxicating liqour or wine in public plazas and public places.
d. Minors are not allowed to buy or drink alcoholic drinks, intoxicating liquor and wine. e. It is the responsibility of owners of stores and any business establishments to limit the selling, disposing of or giving away intoxicating liquor or alcoholic drinks taken or offered inside their stores or business establishments to avoid drunkenness and toward incidence to happen. f. The Municipal Mayor reserves the right to close or revoke the license of any store or business establishments selling, dispossing of and giving away intoxicating liquor or any alcoholic drinks if it is necessary for the interest of public safety and public order. Section 6. Penal Provisions -Violations of any of the provisions of this Ordinance shall be penalized for the first offense, by a fine of not less than five hundred pesos (P500.00) but not more than one thousand pesos (P1,000.00); for the second offense, by a fine of not less than one thousand pesos (P1,000.00) but not more than two thousand pesos (P2,000.00) for the third offense, by cancellation of Mayor's Permit to operate business. Section 7. Previous Ordinances that have provisions which are in conflict with this Ordinance are hereby declared null and void. Section 8. If any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts of provisions thereof which are not effected thereby shall continue and be in full force and effect.
