RESOLVED FURTHER that donation is subject to the terms and conditions mutually agreed by the Municipal Administration and the Philippine Postal Corporation provided for in the Deed of Donation;

RESOLVED FURTHERMORE that Sangguniang Bayan authorizes the Hon. Mayor Edgardo D. Zaragoza to represent the Municipality in the execution of the Deed of Donation.

RESOLVED FINALLY that copies of the Resolution be forwarded to all concerned parties for their information and appropriate action.
