
WHEREAS, following the reconstitution of the Sangguniang Bayan, Standing committees of the Body were re-organized including the OSCA;

WHEREAS, during its reorganization of SB Committees, Kgd. Remedios C. Ramirez was unanimously elected to head the OSCA;


