RESOLUTION REQUESTING FOR THE TRANSFER OF MANAGEMENT AND OWNERSHIP OF AMBULANCE ISSUED TO BILEG TI NARVACAN COOPERATIVE BY THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE TO THE LOCAL GOVERNMENT OF NARVACAN, ILOCOS SUR

WHEREAS, the delivery of basic health services to the municipality is a devolved function of the Government Unit in pursuance to RA 7160 otherwise known as Local Government Code of 1991;

WHEREAS, an ambulance donated by the Philippine Charity Sweepstakes office has been issued to BILEG TI NARVACAN COOPERATIVE represented by a certain Mrs. Juliet Viloria of Narvacan, Ilocos Sur; who ran for MAYORin the 1998 local Elections;

WHEREAS, BILEG TI NARVACAN COOPERATIVE is not registered with the Cooperative Development Authority and is therefore not legally operating under existing laws nor is it accredited by the Municipal Council as a legitimate cooperative;

WHEREAS, the ambulance issued to said unregistered cooperative is being kept at the residence of Mrs. Viloria and disposition of its use is dependent on her decision; but such ambulance is apparently being used to service her political clients;

WHEREAS, the members of the Sangguniang Bayan are aware that the subject ambulance is not used as intended but for political purposes;

NOW THEREFORE, on motion of the Body duly seconded, BE IT RESOLVED AS IT IS HEREBY RESOLVED to request to concerned authorities for the transfer of management and ownership of said ambulance issued to BILEG TI NARVACAN COOPERATIVE to the Local Government Unit of Narvacan, Ilocos Sur.
