RESOLUTION REQUESTING THE HON. ROGELIO SIGNEY, REGIONAL DIRECTOR OF THE DEPARTMENT OF AGRICULTURE FOR HIS ASSISTANCE IN ALLOCATING TWO HUNDRED THOUSAND PESOS (P200,000.00) TO FUND THE REQUIREMENTS OF A DEMO FARM TO BE ESTABLISHED IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, the Municipal Administration places priority interest in agriculture development in support of President Joseph Estrada's food security program;

WHEREAS, the members of the Municipal Council take cognizance of the importance of agriculture development in the municipality and fully support the initiatives of the municipal leadership in enhancing food and crop production of local farmers through technology interventions;

WHEREAS, Municipal Administration through its Municipal Agriculture Office has identified the establishment of a demo farm which will be utilized for modern technology transfer scheme which will benefit local farmers;

WHEREAS, the demo farm shall be managed by the local government unit of Narvacan with the Harbest Agribusiness Corporation, a legal entity, providing the transfer of technology in agricultural crop production;

WHEREAS, the establishment of the demo farm requires substantial funding which the local government unit of Narvacan is sourcing from the Department of Agriculture through its Regional Office;

NOW THEREFORE, on motion duly seconded, BE IT RESOLVED AS IT IS HEREBY RESOLVED to request the Hon. Rogelio Signey, Regional Director of the Department of Agriculture, for his assistance in allocating the amount of TWO HUNDRED THOUSAND PESOS (P200,000.00) to fund the establishment of a demo farm for the transfer of technology in agricultural crop production;

RESOLVED FURTHER that the Municipal Council authorizes the Hon. Charito S. Zaragoza, Municipal Mayor of Narvacan, Ilocos Sur to enter into a Memorandum of Agreement with the Harbest Agribusiness Corporation for and in behalf of the Municipality of Narvacan, Ilocos Sur.

RESOLVED FINALLY that copies of this Resolution be forwarded to the Hon. Rogelio Signey, Regional Director of the Department of Agriculture for his information and approval and to all other concerned parties for their appropriate actions.
