RESOLUTION GRANTING CASH INCENTIVE AWARD TO GRADUATING VALEDICTORIANS FROM THE PRIMARY SCHOOLS AND DAY CARE CENTERS IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, the Municipal Administration puts premium interest on the educational development of its young citizens;

WHEREAS, the provision of incentive schemes to pupils and students in the municipality serves as an opportunity to give motivation and encouragement to them to excel in their education;

WHEREAS, an annual cash incentive award given to deserving graduating pupils and students from the day care centers to primary and elementary schools to secondary schools is a continuing program of the Municipal Administration in partnership with the United Narvacanean Association International, a US-based organization of Narvacaneans;

WHEREAS, effective school year 1998-1999, the annual grant has been modified to exclude recipients from the day care centers and primary schools;

WHEREAS, the Municipal Administration and the Members of this Body see the need to continue granting cash incentives to top graduates of each class in the day care centers and primary schools in the municipality;

WHEREAS, the amount of award granted to each recipient shall be determined by the office of the Mayor in concurrence of the members of the Sangguniang Bayan as a Body;




RESOLVED FINALLY that copies of this resolution be forwarded to all concerned parties for their information and appropriate action.
