RESOLUTION APPROPRIATING THE AMOUNT OF P333,333.00 AS COUNTERPART FUND OF THE LOCAL GOVERNMENT UNIT OF NARVACAN, ILOCOS SUR UNDER THE LGU-DPWH COST-SHARING PROGRAM FOR INFRASTRUCTURE DEVELOPMENT

WHEREAS, the Local Government Unit of Narvacan, Ilocos Sur is a recipient of a one million peso-grant under the LGU-DPWH Cost-sharing Program for Infrastructure Development;

WHEREAS, the Local Government Unit of this municipality has available counterpart fund to finance projects identified under the LGU-DPWH Cost-sharing program;

WHEREAS, such counterpart fund is being appropriated out from the RA 7171 Municipal Share due this municipality in the amount of P333,333.00 and shall be utilized for infrastructure programs qualified under the cost-sharing program;

WHEREAS, these infrastructure projects are concreting of Poblacion Road, Orence-Dasay Road and Camarao-Bantay-Abot Road;




RESOLVED FINALLY that copies of this resolution be forwarded to all concerned parties for their information and appropriate actions.
