RESOLUTION REQUESTING THE DIRECTOR-GENERAL OF THE PHILIPPINE NATIONAL POLICE TO ADVISE LOCAL LEVELS OF THE PNP TO PROVIDE FOR THE SAFETY OF KAGAWAD JOSE CORRALES JR. WHILE IN DETENTION

WHEREAS, Kgd. Jose Corrales Jr. who is charged under criminal case no. 1858 - N is a member of this Sangguniang Bayan of good standing having enjoyed the trust and confidence of the people of this municipality by electing him number one among the eight municipal councilors elected last May 18, 1998;

WHEREAS, Kgd. Jose Corrales is now serving his third term as a municipal councilor and chairs the Committee on Agriculture which is a very vital body in local legislation;

WHEREAS, Kgd. Jose Corrales, a faithful member of the family christian community of Marriage Encounter (ME) Couples for Christ, now creates a void in the local legislative body with his detention affecting therefore the Body's legislative works on agriculture development for the municipality of Narvacan;

WHEREAS, Kgd. Jose Corrales Jr. has been receiving death threats that may endanger his life even while in detention which is now causing burdensome worries to his family, to his colleagues in the Sangguniang Bayan and to the whole community which he committed himself to serve as a local legislator;

WHEREAS, it is the hope of the whole Sangguniang Bayan of this municipality that all safety measures to safeguard his life be provided to Kgd. Jose Corrales Jr. while in detention;

NOW THEREFORE, on motion duly seconded by the Body, BE IT RESOLVED AS IT IS HEREBY RESOLVED to request the Director-General of the Philippine National Police to advise local levels of the PNP to provide all the appropriate safety measures to safeguard the life of Kgd. Jose Corrales Jr. while in detention.

RESOLVED FINALLY that copies of this Resolution be forwarded to the Director-General of the PNP, Regional Director of the PNP, Provincial Director of the PNP and the Provincial Governor for their information and appropriate actions.
