RESOLUTION ADOPTING THE 1999 ANNUAL DEVELOPMENT PLAN OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR AS PROPOSED BY THE MUNICIPAL DEVELOPMENT COUNCIL, WITH AMENDMENTS

WHEREAS, the Municipal Administration implements development projects funded from the 20% Annual Internal Revenue Allotment which enable the local government to sustain its development efforts;

WHEREAS, the Municipal Development Council, a multi-sectoral council mandated to identify and prioritize development projects, has come with its list of priority projects and their corresponding allocation which was submitted to the Sangguniang Bayan through Resolution No. 01, Series of 1999;

WHEREAS, after careful and intensive study on the proposed projects and appropriations, the members of the Sangguniang Bayan adopted the proposed projects with their corresponding appropriations including certain amendments to the Municipal Development Council Resolution No. 01;
