RESOLUTION REQUESTING THE HON. LEONARDO Q. MONTEMAYOR, SECRETARY OF THE DEPARTMENT OF AGRICULTURE, THROUGH DIRECTOR ROGELIO CONCEPCION OF THE BUREAU OF SOIL AND WATER MANAGEMENT FOR HIS APPROVAL FOR FUNDING ASSISTANCE FOR THE SUCOC DIVERSION DAM PROJECT IN THE AMOUNT OF P1,160,609.88.

WHEREAS, the development of the agriculture sector in the community is a major concern of the Local Government Unit of our municipality;

WHEREAS, the municipality of Narvacan is basically an agricultural community much of it being the principal source of livelihood of the local folks;

WHEREAS, the Municipal Agriculture Office in cooperation with the regional office of the Department of Agriculture has identified the Sucoc Diversion Dam project in Barangay Sucoc as a major project that will pave the way for a more intensified agricultural development in the community;


WHEREAS, the Sucoc Diversion Dam project has an approved cost estimate of P1,160,609.88;
