PEROS, PROVINCIAL AGRARIAN REFORM OFFICER, FOR HIS ENDORSEMENT TO THE CENTRAL OFFICE OF THE DEPARTMENT OF AGRARIAN REFORM FOR THE UTILIZATION OF THE CONTINGENCY FUNDS APPROPRIATED FROM THE CAPUNGDULAN FARM-TO-MARKET ROAD PROJECT AND LABAWA FARM-TO-MARKET ROAD PROJECT FOR THE ADDITIONAL CONCRETING WORK FOR THE NAGREBCAN FARM-TO-MARKET ROAD PROJECT SITUATED IN BARANGAY CAGAYUNGAN, NARVACAN, ILOCOS SUR, UNDER THE DAR-ADB ASSISTED PROJECTS FOR AGRARIAN REFORM COMMUNITIES

WHEREAS, the Municipal Administration places priority interest in its agriculture development program, providing thereof infrastructures such as farm-to-market roads;

WHEREAS, the contingency funds appropriated from the Capungdulan and Labawa farm-to-market roads have not been utilized;


WHEREAS, the on-going Nagrebcan farm-to-market road in Barangay Cagayungan needs additional funding to finance the needed additional concreting work requirement;
