RESOLUTION AMENDING ORDINANCE NO. 98-05 series of 1998

WHEREAS, the members of the Sangguniang Bayan of Narvacan, Ilocos Sur are cognizant of the need to implement an effective traffic management in the municipality so as to provide travelling convenience and comfort to the public;

NOW THEREFORE, on motion of Kgd. Rafael Cachola, duly seconded, BE IT RESOLVED AS IT IS HEREBY REOLVED to amend Ordinance No. 98-05 series of 1998, instituting certain provisions thereof to provide better traffic management and control in the municipality.

ORDINANCE NO. 98-05

AS AMENDED

AN ORDINANCE REGULATING TRAFFIC ON MUNICIPAL STREETS AND BARANGAY ROADS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

BE IT ENACTED by the Sangguniang Bayan members in session assembled that:

Section 1 - The Sangguniang Bayan under its legislative authority hereby promulgates Rules and Regulations for the proper and effective traffic management in the municipality of Narvacan, Ilocos Sur;

Section 2 - The temporary closure of certain streets or roads is authorized during market days (Sundays), agri-industrial fairs, community parades, implementation of public works, projects and other meritorious, lawful purposes which promote public welfare provided however that adequate alternate facilities/routes are made available for the public;

Section 3 - No street or road will be temporarily closed for purely private uses which are prejudicial to public interest and welfare;

Section 4 - Traffic signs will be strategically placed at streets/road sections to guide motorists and the public to effect smooth, orderly flow of traffic and to minimize traffic-related accidents;

Section 5 - One-way Streets

The following streets are one-way:

From National Highway through Bonifacio Street- Daily 6:00 am - 6:00 pm
Rizal Park West Entrance along San Jose St. - Sundays only

Section 6 -

(a) Proper parking at designated areas for tricycle, jeepneys, cargo trucks, etc. marked with painted lines must be strictly observed at all times to maximize use of limited space and ease congestion and for faster mobility of vehicles of the travelling public'

(b) Double parking is prohibited.

(c) Unloading of commercial goods:

- no unloading of commercial good shall be done from 7 o'clock a.m. onward.
unloading of commercial items shall be done from 5:00 a.m. to 7:00 o'clock a.m. everyday except Sunday.

- no loading and unloading of goods shall be done within 50 meters from road approaches to the town proper along Old National Highway in Barangay Sta. Lucia and Lara St. in Barangay San Jose.

- No cargo/commercial truck shall park on streets along the vicinity of the Narvacan Public Market. Parking spaces are provided along Damasco street in Barangay San Jose. and other streets that may hereafter be designated.

(d) Tricycles must unload and load passengers only at designated areas.

Section 7- Courtesy

Traffic policemen and traffic aides must at all times when on duty, show courtesy to the travelling public

Section 7 - Penalty - violators of this Ordinance will be meted fines as specified:


1st offense - - - - P 50.00
2nd offense - - - 100.00
3rd offense - - - 300.00

Section 8 - Effectivity - This ordinance shall take effect - 30 days after its approval.
