RESOLUTION REQUESTING DR. JOSE G. CAMACHO, DIVISION SUPERINTENDENT OF THE PROVINCIAL OFFICE OF THE DEPARTMENT OF EDUCATION, CULTURE AND SPORTS TO EXTEND PRIORITY PREFERENCE TO QUALIFIED APPLICANT FROM NARVACAN, ILOCOS SUR TO FILL UP THE POSITION OF ADMINISTRATIVE OFFICER II OF THE NARVACAN NATIONAL CENTRAL HIGH SCHOOL, NARVACAN, ILOCOS SUR.

WHEREAS, the Narvacan National Central High School is a secondary school in Narvacan, Ilocos Sur which can provide employment opportunities to qualified local residents of the municipality;

WHEREAS, the Narvacan National Central High School has a current vacancy for the item of Administrative Officer II;

WHEREAS, the vacant position is being applied for by qualified applicants from Narvacan, Ilocos Sur;

WHEREAS, the members of the Sangguniang Bayan are cognizant of the provisions of Republic Act No. 8190 which grants priority to residents of the Municipality where the school is located in the appointment or assignment of school personnel;


WHEREAS, the Municipal Administration endorses these applicants from Narvacan, Ilocos Sur who are better adapted to the community and whom we can rely to cooperate and render extra work for community programs and projects;

NOW THEREFORE on motion of Kagawad Irvin R. Lim duly seconded by the Body BE IT RESOLVED AS IT IS HEREBY RESOLVED to request Dr. Jose G. Camacho, Division Superintendent of the Provincial Office of the Department of Education, Culture and Sports, to give priority preference to qualified applicants from Narvacan, Ilocos Sur to fill up the position of Administrative Officer II of the Narvacan National Central High School, Narvacan, Ilocos Sur.


RESOLVED FURTHER that a copy of this Resolution be forwarded to Dr. Jose G. Camacho for his information and appropriate action.
