RESOLUTION REQUESTING THE **HON. ROSARIO 'DINKY' SOLAIMAN, SECRETARY OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT** FOR HER ASSISTANCE IN ALLOCATING FUNDS FOR THE MUNICIPALITY OF NARVACAN, ILOCOS SUR TO FUND RELIEF EFFORTS OF THE LOCAL GOVERNMENT FOR VICTIMS OF TYPHOON FERIA IN THE MUNICIPALITY

WHEREAS, the Municipality of Narvacan in Ilocos Sur was hardest hit by typhoon FERIA that brought untold damages to agricultural crops, livestock, river controls and seawalls, secondary bridges, barangays roads, homes and other personal properties of affected families in all of the 34 barangays of Narvacan, Ilocos Sur;

WHEREAS, relief efforts have been very minimal owing to the need for a more substantial amount of money to fund the over-all recovery, restructuring and relief operations of the Local Government Unity of Narvacan, Ilocos Sur;

WHEREAS, some reported 1,400 families have been affected by this calamity, hence the urgent need for assistance to these low-income families;

WHEREAS, typhoon FERIA left the people and the local government of Narvacan, Ilocos Sur, as in other towns of Ilocos Sur, financially-draining aftermath;

WHEREAS, the members of the Municipal Council and the Municipal Administration are sourcing funds to augment relief activities initiated by the Local Government of Narvacan, Ilocos Sur;

NOW THEREFORE, on motion of **Kgd. Oscar Potencion**, duly seconded by the Body, BE IT RESOLVED AS IT IS HEREBY RESOLVED to request the **Hon. Rosario 'Dinky' Solaiman, Secretary of the Department of Social Welfare and Development**, for her assistance in allocating funds for the Municipality of Narvacan, Ilocos Sur to fund relief efforts of the Local Government for victims of typhoon FERIA in the Municipality.

RESOLVED FINALLY that a copy of this Resolution be forwarded to the **Hon. Rosario 'Dinky' Solaiman, Secretary of the Department of Social Welfare and Development** for her information and approval.






