RESOLUTION SUPPORTING THE LEAGUE OF MUNICIPALITIES OF THE PHILIPPINES (LMP) ND RESOLUTION NO. 006-2004 AND AUTHORIZING THE DEPARTMENT OF BUDGET AND MANAGEMENT TO ADVANCE AND DIRECTLY RELEASE THE AMOUNT OF P1.5 BILLION SHARE TO THE MUNICIPALITIES AT P1 MILLION PER MUNICIPALITY FOR THE CONCRETING OF THEIR ROADS PURSUANT TO THE LGU-NATIONAL GOVERNMENT COST-SHARING INFRASTRUCTURE PROGRAM.

WHEREAS, the League of Municipalities of the Philippines (LMP) on October 21, 2004 in Cebu City at the meeting of the members of the National Directorate passed and approved ND Resolution No. 006-2004 to defer the P10 Billion increase in the LGU's IRA share for Year 2005 provided the national government will advance and release automatically the P1.5 Billion share directly to all municipalities in the country at P1 Million per municipality pursuant to the LGU-National Government's Cost-Sharing Infrastructure Program;

WHEREAS, the said resolution of the LMP also approved the proposal to Congress to defer the Sangguniang Kabataan and Barangay Elections in 2005;

WHEREAS, we find ND Resolution No. 006-2004 of the LMP to be highly justified and reasonable under the present hard economic conditions the country faces today in support to the realization of the 10-point legacy agenda of Her Excellency Gloria Macapagal-Arroyo;

WHEREAS, our municipality is however in dire need in the implementation of vital infrastructure projects particularly in the concreting of our roads which are needed by our constituents in their day to day activities;

NOW THEREFORE, premises considered and upon motion of Hon. SB Member Jose T. Corrales, Jr. and duly seconded by the Body be it

RESOLVED AS IT IS HEREBY RESOLVED, that this august body hereby passed and approved this resolution adopting the LMP ND Resolution No. 006-2004 and authorizing the Department of Budget and Management to immediately release the P1 Million advance share to our municipality for the concreting of our roads;


RESOLVED FURTHER, that copies of this resolution be furnished the Honorable Secretary Emilia T. Boncodin, Department of Budget and Management, and Mayor Ramon N. Guico, Jr., National President of the League of Municipalities of the Philippines.
