RESOLUTION EARNESTLY REQUESTING THE **HON. LUIS C. SINGSON**, GOVERNOR, PROVINCE OF ILOCOS SUR FOR HIS FINANCIAL ASSISTANCE AMOUNTING TO FIVE MILLION PESOS FOR THE CONSTRUCTION OF A BASKETBALL COVERED COURT AND IMPROVEMENT OF THE MUNICIPAL KIOSK AT NARVACAN, ILOCOS SUR

WHEREAS, the Municipal Administration's infrastructure and rehabilitation program is a development priority which will focus on the improvement of various old structures and projects within the municipality;

WHEREAS, this goal, however, is constrained by financial limitation as the municipal administration depends on project grants given by the national government, the congressman and the senators who are supportive to our development efforts;

WHEREAS, the improvement and construction of a covered basketball court and improvement of the Municipal Kiosk will eventually serve as a fitting venue to conduct significant activities, programs, gatherings especially the celebration of the Annual Town Fiesta of the municipality;

WHEREAS, the members of the municipal council are cognizant of the need to provide the people better and secured place to conduct such important activities especially during rainy seasons;


WHEREAS, the construction of a basketball covered court and the improvement of the Municipal Kiosk will serve as an income-generating establishment where big events of the municipality or even the whole province will be staged;

NOW THEREFORE, on motion of **Kgd. Margarito Tejada**, Committee Chairman on Infrastructure Development, duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to request the **Hon. LUIS C, SINGSON** for his financial assistance in the amount of five million pesos for the construction of a basketball covered court and improvement of the Municipal Kiosk at Narvacan, Ilocos Sur.

RESOLVED FURTHER that this resolution be forwarded to the Hon. LUIS C. SINGSON for his kind information and appropriate action.
