**WHEREAS**, the Municipal Auditorium is one of the main attraction of the municipality and it is where all the activities, gatherings, occasions especially the celebration of the annual town fiesta are being held;

**WHEREAS**, its improvement will eventually cater all undertakings of the whole municipality and will surely accomodate best our constituents during grand gatherings and occasions;


**WHEREAS**, the Municipal Administration, operating under its current budget, cannot cope with the funding requirement of the project and is now exploring all possible funding sources to finance the renovation of the Municipal Auditorium;

**NOW THEREFORE**, on motion of **Kgd. Rafael Cachola**, duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to request the **HON. SERGIO OSMEÑA**, Senator, Senate of the Philippines for his financial assistance amounting to five hundred thousand pesos for the general redevelopment of the Municipal Auditorium of Narvacan, Ilocos Sur.


**RESOLVED FINALLY** that a copy of this Resolution be forwarded to the **Hon. Sergio Osmeña** for his information and immediate approval.
