YAP, SECRETARY OF THE DEPARTMENT OF AGRICULTURE, FOR HIS FINANCIAL ASSISTANCE FOR THE PURCHASE OF CHOPPER/SHREDDER FOR USE IN THE MANUFACTURE OF ORGANIC FERTILIZER FOR DISTRIBUTION TO LOCAL FARMERS' ASSOCIATIONS/COOPERATIVES IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, the rising cost of in-organic fertilizers prompts local farmers to result to alternative fertilizers such as lorganic ones to lessen the cost of crop production;

WHEREAS, the Local Government Unit of Narvacan, Ilocos Sur has allocated the amount of P500,000.00 as its counterpart fund for the purchase of a chopper/shredder;
