**RESOLUTION REQUESTING HOUSING AND LAND USE REGULATORY BOARD (HLURB) TO DEVOLVE THE POWER TO ISSUE ZONING AND LOCATIONAL CLEARANCES TO THE MUNICIPALITY OF NARVACAN, PROVINCE OF ILOCOS SUR**

WHEREAS, the Housing and Land Use Regulatory Board (HLURB), as a national agency has the power and authority to issue zoning and locational clearances;

WHEREAS, the Sangguniang Bayan respectfully pray that the said power be devolved to the municipal government of Narvacan after its CLUP has already been adopted and eventually approved by the Sangguniang Panlalawigan;




