**RESOLUTION GRANTING THE WORLDWIDE NARVACANEANS ITS

NOW THEREFORE on motion duly seconded by the August Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED TO ACCEPT THE FINANCIAL DONATION AND GRANT THE WORLDWIDE NARVACANEANS IN ITS UTILIZATION OF THE LEFT AND RIGHT WING OF THE GROUND FLOOR OF THE PEOPLE'S CENTER FOR THE OPERATION OF THE WWN EMERGENCY RESPONSE CENTER.**
