RESOLUTION IMMEDIATELY CLOSING THE M.P. DECHAVES SARI-SARI STORE OWNED BY MS. MARIVIC DECHAVES AT BARANGAY STA. LUCIA, NARVACAN, ILOCOS SUR

WHEREAS, as per records filed and kept at the Licensing Office of this municipality, Ms. Marivic Dechaves applied for and was granted a business permit for a sari-sari store with beer, cigar, liquor at Brgy. Sta. Lucia, Narvacan, Ilocos Sur;

WHEREAS, it has come to the attention of and has proven by the Sangguniang Bayan of Narvacan that Ms. Dechaves is also operating a videoke bar within her sari-sari store;

WHEREAS, the said videoke bar has always been the subject of complaints of the neighboring residents blaming for its nuisance especially at later hours of the night and even at dawn time;

WHEREAS, as per municipal police journal, the above-mentioned videoke bar has been the venue of troubles and crimes besetting the municipality's peace and order;

WHEREAS, the Members of the Legislative Body, after careful deliberation, resolved for the immediate closure of the M.P. Dechaves sari-sari store owned by Ms. Marivic Dechaves at Brgy. Sta. Lucia, Narvacan, Ilocos Sur having no proper permit and having disturbed the tranquility of the municipality;

NOW THEREFORE, on motion of Councilor Carlito T. Corrales, Chairman, Committee on Peace and Order, duly seconded by the Body, BE IT RESOLVED AS IT IS HEREBY RESOLVED to immediately close the M.P. Dechaves sari-sari store owned by Ms. Marivic Dechaves at Brgy. Sta. Lucia, Narvacan, Ilocos Sur, in the interest of peace, public safety and welfare;

RESOLVED FURTHER that a copy of this Resolution be forwarded to the Local PNP to implement the immediate closure of the M.P. Dechaves sari-sari store.
