**RESOLUTION EARNESTLY REQUESTING THE HON. MANUEL VILLAR, SENATOR, SENATE OF THE PHILIPPINES, FOR HIS ASSISTANCE IN ALLOCATING FUNDS AMOUNTING TO FOUR HUNDRED THOUSAND PESOS (Php400,000.00) FOR THE CONSTRUCTION/IMPROVEMENT OF MARGAAY FARM-TO-MARKET ROAD IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR**

**WHEREAS**, the Municipal Administration has placed on top of its development agenda the construction and improvement of farm-to-market roads which will serve as key links from the barangays to the commercial center of the town;

**WHEREAS**, this goal, however, is constrained by financial limitation as the Municipal Administration depends on financial assistance from the national government, senators and congressmen who are supportive of our development effort;

**WHEREAS**, the Municipal Administration urgently needs development funds to satisfy the needs of our constituents for better transportation facilities, a vital infrastructure support to accelerate development in the countryside in line with the economic development program of the national government;

**WHEREAS**, the Sangguniang Bayan of Narvacan, Ilocos Sur always trusts in the sincere concern of **Sen. Manuel Villar** in sharing allocation to finance vital countryside infrastructure program;






