RESOLUTION AUTHORIZING MAYOR EDGARDO D. ZARAGOZA OF THE MUNICIPALITY OF NARVACAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF EDUCATION (DepEd) REGION I, DIVISION OF ILOCOS SUR FOR THE PURPOSE SPECIFIED HEREIN

WHEREAS, the Municipality of Narvacan, Ilocos Sur recognizes the need to provide its constituents with quality education at par with other learning institutions as responsive to developments in technology;

WHEREAS, the DepEd is the national agency with the mandate of providing quality education to the constituents of the municipality of Narvacan specifically Narvacan North District through its six (6) primary schools, fourteen (14) elementary schools and two (2) Integrated high schools and to provide access to constituents of schoolless barangay of Cadacad, Narvacan, Ilocos Sur;

WHEREAS, the DepEd, notwithstanding the budgetary parameters, needs to implement its programs, and signifies that there are no appropriations for the honoraria of two (2) volunteer teachers of the proposed **Cadacad Primary School, Narvacan North District**;

WHEREAS, this Resolution authorizes Mayor Edgardo D. Zaragoza to enter into a Memorandum of Agreement (MOA) with the DepEd, Region I, Division of Ilocos Sur, which stipulates that the Municipality of Narvacan, Ilocos Sur, being a second (2ND) income class municipality commits to fund the honoraria of the teaching personnel of the proposed **Cadacad Primary School**, Narvacan North District, until such time that DepEd and Department of Budget and Management shall have approved the formal opening of **Cadacad Primary School**;


WHEREAS, the said MOA stipulates also that the DepEd's counterpart is its commitment to provide the necessary teaching personnel to ensure good quality of education;

NOW THEREFORE, on motion of Councilor Irvin R. Lim, Chairman, Committee on Education, duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize Mayor Edgardo D. Zaragoza of the Municipality of Narvacan to enter into a Memorandum of Agreement (MOA) with the Department of Education (DepEd), Region I, Division of Ilocos Sur, for the purpose specified herein;

RESOLVED FURTHER that a copy of this Resolution be furnished to DepEd, Region I, Division of Ilocos Sur, represented by **ROGELIO D. GALAT, Ed.D., CESO V**, Schools Division Superintendent for his information.




