**RESOLUTION DESIGNATING IRVIN R. LIM, CARLITO T. CORRALES, AND

OFFICIAL REPRESENTATIVES TO THE CITY EXCHANGE PROGRAM
OF THE MUNICIPALITY OF NARVACAN
AND CITY OF GROVER BEACH, CALIFORNIA, USA**

WHEREAS, the Sisterhood Pact between the Municipality of Narvacan and City of Grover Beach, California which was forged on 12 October 1991 at Grover Beach, California has improved and enriched cultural, educational, social and economic ties between the two cities through programs and projects initiated by the City Council of Grover Beach and the Narvacan Association of Central California (NACC);

WHEREAS, the City Council of Grover Beach had approved the City Exchange Program, an exchange program of qualified employees from the local government unit of the Municipality of Narvacan and the city government of Grover Beach;

WHEREAS, the City Exchange Program is an opportunity for our employees to acquire new insights on the system of city governance which may be practical and relevant to be adopted in our local governance thereby improving systems and procedures, policies and programs;

WHEREAS, the City Exchange Program will have its implementation this year scheduled on October 7, 2006 with our Municipal Administration sending three official program grantees to Grover Beach, California, USA;

NOW THEREFORE, on motion of Councilor Irvin R. Lim, duly seconded by the Body,
BE IT RESOLVED AS IT IS HEREBY RESOLVED to appoint Irvin R. Lim, Carlito T. Corrales, and Eliezer S. Corrales, Members of the Sangguniang Bayan, as the municipality's official representatives to the City Exchange Program on October 7, 2006 at Grover Beach, California, USA;

RESOLVED FURTHER that copies of this Resolution be forwarded to the **HON. MAYOR LARRY VERSAO** of Grover Beach for the Members of the City Council and to the **HON. CONSUL GENERAL** of the US Embassy, Manila for their information and facilitation for the issuance of the grantees' visas.
