**RESOLUTION REQUESTING POLICE DIRECTOR GENERAL ARTURO C. LOMIBAO, CHIEF, PHILIPPINE NATIONAL POLICE, THE IMMEDIATE REPLACEMENT OF THE ISUZU 4 X 2 PATROL JEEP AND MOTORCYCLE OF THE NARVACAN PNP STATION, ILOCOS SUR**

**WHEREAS**, the Municipal Administration is sincerely committed to pursue a vision of a peaceful and progressive community, creating community concern and awareness to drum up support of all constituents;

**WHEREAS**, the Narvacan Police Station headed by **Police Chief Inspector Marlo A. Castillo** has come up with Action Plans and Programs for the enactment of measures to promote the safety and welfare of the people;

**WHEREAS**, one of these action plans and programs is the mobility and visibility of the PNP Force which is very crucial in helping preempt and reduce criminality in the community thru law enforcement visibility within the area which requires round-the-clock patrols;

Lomibao**, Chief, Philippine National Police, the immediate replacement of the Isuzu 4 x 2 patrol jeep and motorcycle of the Narvacan PNP Station, Ilocos Sur which is in the interest of public service;




