**RESOLUTION EARNESTLY REQUESTING THE NATIONAL
TELECOMMUNICATIONS COMMISSION (NTC) TO COMPEL
THE MANAGEMENT OF DIGITEL TO IMPROVE ITS FACILITIES AND SERVICES,
AND TO INSTALL ADDITIONAL LINES IN NARVACAN, ILOCOS SUR**

WHEREAS, the Digital Telecommunications, Incorporated (DIGITEL) has a franchise to deliver telecommunications services to our municipality;

WHEREAS, the members of the Sangguniang Bayan of this Municipality take cognizance of the fact that the DIGITEL is supposed to provide adequate and effective telecommunications services to its clients;

WHEREAS, the DIGITEL has been the subject of public complaints for its inefficiency of service and ineffective management which prompted this Body to file this Resolution;

WHEREAS, it is important that the public deserves better telecommunications services from the DIGITEL since this is an entity mandated to serve well the public;

WHEREAS, the Municipality of Narvacan, Ilocos Sur is a growth center of commerce and trade with the increasing volume of business and related gainful activities contributing to the progress of the community; thus creating the need of telephones for faster and more economical transactions;

WHEREAS, the Municipality has a sizable share of overseas Filipino workers and balikbayans who need communication facilities in order to make direct long distance calls to their families back home to relay urgent messages;

NOW THEREFORE, on motion of Councilor Margarito A. Tejada duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to pass this Resolution to the National Telecommunications Commission (NTC) to compel the management of DIGITEL to improve its facilities and services, and to install additional lines in Narvacan, Ilocos Sur;

RESOLVED FURTHER to forward this Resolution to Mr. Roberto Lastimoso, Commissioner, National Telecommunications Commission (NTC), for his immediate and favorable action.
