**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR EDGARDO D. ZARAGOZA OF THE MUNICIPALITY OF NARVACAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH JON TIMOTHY CORPUS FOR THE PURPOSE SPECIFIED HEREIN**

**WHEREAS**, the Municipality of Narvacan is undertaking a general redevelopment and beautification of its municipal plaza located in front of the Municipal Hall at downtown, Narvacan, Ilocos Sur;

**WHEREAS**, in order to maximize the efforts of beautification, JON TIMOTHY CORPUS, represented by his Attorney-in-fact ATTY. ROMAN MARIO V. PANEM, shall extend financial assistance by donating a finished fountain in the plaza to be named after his father "ANTONIO C. CORPUS MEMORIAL FOUNTAIN";

**WHEREAS**, JON TIMOTHY CORPUS shall finance and supervise the cost, design and construction of said fountain to be built by a commissioned contractor of its own choice; while the Municipality of Narvacan will prepare the design, construction and structural drawing for the fountain at its own expense;

**NOW THEREFORE**, on motion of Councilor Margarito A. Tejada, Chairman, Committee on Infrastructure, duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize Municipal Mayor Edgardo D. Zaragoza to enter into a Memorandum of Agreement with JON TIMOTHY CORPUS, which stipulates among others that the Municipality of Narvacan shall maintain and operate the fountain upon completion and ultimate turnover.

**RESOLVED FURTHER** that JON TIMOTHY CORPUS shall complete the fountain on or before October 15, 2006.

**RESOLVED FINALLY** that copies of this Resolution be furnished to all parties concerned for their information and reference.




