Cac located at Lungog, Narvacan, Ilocos Sur in the vicinity of the barangay road going to Barangay Camarao has passed inspection and was issued a Zoning Certification from the Housing and Land Use Regulatory Board (HLURB), Regional Office I, San Fernando, La Union;


