RESOLUTION AUTHORIZING MAYOR EDGARDO D. ZARAGOZA OF THE MUNICIPALITY OF NARVACAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD UNIT I (DA RFU-I) FOR THE PURPOSE SPECIFIED HEREIN

WHEREAS, the Department of Agriculture (DA) through its Regional Field Unit I (RFU-I) is implementing the Ginintuang Masaganang Ani-Corn Program whereby it (DA RFU-I) provides farm tractor with heavy duty implements / attachments under credit terms cost sharing arrangements with farmer organizations, LGUs, and private tractor pool;

WHEREAS, to benefit its farmer-constituents and to minimize agricultural cost while maximizing production, the LGU-Narvacan intends to avail of the said assistance;

WHEREAS, this Resolution authorizes Mayor Edgardo D. Zaragoza to enter into a Memorandum of Agreement (MOA) with the DA RFU-I which stipulates that both parties, the DA RFU-I and LGU-Narvacan, shall allocate an amount based on cost-sharing arrangement, of One Million Pesos (P 1,000,000.00) each for the procurement of one (1) unit 4 WD Tractor with heavy duty implements / attachments;

WHEREAS, the said MOA stipulates also that the DA RFU-I's counterpart is a soft-loan without interest payable in five years by the LGU-Narvacan;

NOW THEREFORE, on motion of Councilor Oscar R. Potencion, Committee Chairman on Agriculture, duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize Mayor Edgardo D. Zaragoza of the Municipality of Narvacan to enter into a Memorandum of Agreement (MOA) with the Department of Agriculture Regional Field Unit I (DA RFU-I) for the purpose specified herein;

RESOLVED FURTHER that this Resolution be furnished to DA RFU-I, represented by **NESTOR DOMENDEN**, OIC Regional Executive Director, to manifest adherence of the Municipality of Narvacan, Ilocos Sur to the schedule of amortization set forth by the Memorandum of Agreement (MOA).
