RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR EDGARDO D. ZARAGOZA OF THE MUNICIPALITY OF NARVACAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRARIAN REFORM (DAR) FOR THE PURPOSE SPECIFIED HEREIN

WHEREAS, the construction / improvement of farm-to-market road at Lungog, Narvacan, Ilocos Sur is one of the top priorities in the infrastructure program of the Municipal Administration;

WHEREAS, the said project, when fully realized, will provide better and faster means of transporting farm products to the market and promoting inter-trade relations with neighboring barangays, thereby enhancing economic growth and development of the whole community;

WHEREAS, the said project has been approved and the Department of Agrarian Reform has allocated the amount of three million pesos (P3,000,000.00) for its realization;

WHEREAS, the Department of Agrarian Reform (DAR) collaborate with local government units to assist in the implementation of support services such as infrastructure and agri-enterprise development projects;

WHEREAS, the Municipal Government signifies to be a conduit in implementing infrastructure projects like roads and bridges which can serve a greater number of its constituents;

NOW THEREFORE, on motion duly seconded, **RESOLVED AS IT IS HEREBY RESOLVED** to pass this Resolution authorizing Mayor Edgardo D. Zaragoza to enter into a Memorandum of Agreement with the DAR which stipulates among others that DAR shall provide the amount of three million pesos (**P3,000,000.00**) for the construction / improvement of farm-to-market road at Lungog, Narvacan, Ilocos Sur, to be implemented by the municipal government of Narvacan, Ilocos Sur;

RESOLVED FURTHER that upon signing of the MOA, the DAR Central Office shall download a mobilization fund amounting to 15% of the project fund and the subsequent release shall be based on the physical and financial report submitted by the municipality of Narvacan;

RESOLVED FINALLY that this Resolution be furnished to DAR to manifest willingness and capability of the municipality of Narvacan, Ilocos Sur, as a partner of this endeavor which benefits the whole community.
