RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR EDGARDO D. ZARAGOZA OF THE MUNICIPALITY OF NARVACAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRARIAN REFORM (DAR) FOR THE PURPOSE SPECIFIED HEREIN

**RESOLVED FURTHER** that upon signing of the MOA, the DAR Central Office shall download a mobilization fund amounting to 15% of the project fund and the subsequent release shall be based on the physical and financial report submitted by the municipality of Narvacan;

**RESOLVED FINALLY** that this Resolution be furnished to DAR to manifest willingness and capability of the municipality of Narvacan, Ilocos Sur, as a partner of this endeavor which benefits the whole community.
