RESOLUTION IMMEDIATELY CLOSING THE LARGE SCALE PIGGERY OWNED BY MR. AND MRS. PEREGRINO C. CAC OF BARANGAY LUNGOG, NARVACAN, ILOCOS SUR

WHEREAS, the Barangay Council of Brgy. Lungog, Narvacan, Ilocos Sur passed and approved Barangay Resolution No. 001, Series of 2005 Resolution Strongly Recommending To The Honorable Mayor Edgardo D. Zaragoza The Closure Of A Large Scale Piggery Business Owned By Mr. And Mrs. Peregrino C. Cac Of Barangay Lungog, Narvacan, Ilocos Sur Or Any Action That May Be Deemed Necessary;

WHEREAS, the Parents Teachers And Community Association (PTCA) of Lungog Integrated School, Lungog, Narvacan, Ilocos Sur also passed and approved Resolution No. 01, Series of 2005 Resolution Strongly Recommending To The Honorable Mayor Edgardo D. Zaragoza The Closure Of A Large Scale Piggery Business Owned By Mr. And Mrs. Peregrino C. Cac Of Barangay Lungog, Narvacan, Ilocos Sur;

WHEREAS, the Municipal Health Monitoring Team headed by Councilor Teofilo M. Cabrerros, Chairman, Committee on Health inspected the said piggery and found out that it has violated the law;

WHEREAS, the members of the Sangguniang Bayan of Narvacan, Ilocos Sur, after careful deliberation, decided for the immediate closure of the piggery of Mr. and Mrs. Cac having violated environmental and zoning ordinances as per the Sangguniang Bayan's findings and the Investigation Report of the Environmental Management Bureau, San Fernando City, La Union dated March 3, 2005, to wit: **a)** the piggery of Mr. and Mrs. Peregrino C. Cac is located in a residential area; **b)** the piggery has exceeded 70 heads, a violation of the guidelines of a backyard piggery; **c)** the owner operates his piggery without Environmental Compliance Certificate, a violation of Section 4 of P.D. 1586; **d)** the owner constructed waste water treatment facility which is not covered by waste water discharge permit, a violation of Republic Act 9275; and, **e)** the piggery emits a very foul odor which poses health hazard to the neighborhood and to the schoolchildren;

NOW THEREFORE, on motion of Councilor Teofilo M. Cabrerros, Chairman, Committee on Health, duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to immediately close the large scale piggery owned by Mr. and Mrs. Peregrino C. Cac of Barangay Lungog, Narvacan, Ilocos Sur;

RESOLVED FURTHER that copies of this Resolution be forwarded to Mr. and Mrs. Peregrino C. Cac; to the Brgy. Council of Lungog, Narvacan; to the Local PNP; to the Department of the Environment and Natural Resources, Vigan City; and to the Office of the Environmental Management Bureau, San Fernando City, La Union for their information and reference.


