RESOLUTION AUTHORIZING HON. EDGARDO D. ZARAGOZA, MUNICIPAL MAYOR, NARVACAN, ILOCOS SUR AND/OR MR. SAMUEL M. CORDERO AND MR. FLORO B. TADEO, MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR AND SENIOR ADMINISTRATIVE ASSISTANT III RESPECTIVELY, TO REPRESENT THE MUNICIPAL GOVERNMENT IN THE EJECTMENT CASE FILED BY THE MUNICIPALITY OF NARVACAN AGAINST ANGEL CANOSA DOCKETED AS CIVIL CASE NO. 2580-N PENDING BEFORE THE SALA OF JUDGE ROGELIO RINGPIS, OF THE 4TH MUNICIPAL CIRCUIT TRIAL COURT

WHEREAS, the local government unit of Narvacan desires for the faster resolution of the ejectment case filed by the Municipality of Narvacan against Angel Canosa who occupied and constructed structures in a government lot at Sulvec, Narvacan, Ilocos Sur;

WHEREAS, the Municipality of Narvacan has proprietary rights in the said parcel of land which the legendary Spanish Watch Tower is constructed;

WHEREAS, decades ago, said parcel of lot has been converted by the National Historical Institute as one of the historical sites in Ilocos Sur needed to be preserved;


WHEREAS, the resolution of the said case will eventually give the municipal government the legal rights to restore, develop, and preserve the Legendary Watch Tower;

WHEREAS, premises considered on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize Hon. Edgardo D. Zaragoza, Municipal Mayor, Narvacan, Ilocos Sur and/or Mr. Samuel M. Cordero, Municipal Planning and Development Coordinator, and Mr. Floro B. Tadeo, Senior Administrative Assistant III, to represent the Municipal Government in the Civil Case No. 2580-N- Municipality of Narvacan, Ilocos Sur vs. Angel Canosa.




