RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR EDGARDO D. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE BUREAU OF SOILS AND WATER MANAGEMENT (BSWM) AND THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD UNIT I (DA RFU I) FOR THE PURPOSE SPECIFIED HEREIN

WHEREAS, the Bureau of Soils and Water Management (BSWM) has allocated funds for the construction of Small Scale Irrigation Project (SSIP) for rainfed barangays which will provide supplemental source of irrigation and prevent soil erosion, as well as flooding of farm lands;

WHEREAS, the DA RFU I under the GMA Program, is providing SSIP , particularly the establishment of small water impounding project/diversion dams to mitigate the effect of drought and flooding;

WHEREAS, the Local Government Unit of Narvacan has signified its intention to undertake the construction of Small Water Impounding Project (SWIP) in Barangay Sucoc with a project cost of Five Million Pesos (P 5,000,000.00);

WHEREAS, the BSWM, the DA RFU I, and the Local Government Unit of Narvacan have agreed to cooperate and jointly implement the said project;

WHEREAS, this Resolution authorizes Mayor Edgardo D. Zaragoza to enter into a Memorandum of Agreement (MOA) with the BSWM and DA RFU I which stipulates that the BSWM shall transfer 60% of the total approved fund to the LGU upon signing of the MOA; 30% will be transferred upon submission of the Notice of Award and Notice to Proceed by the LGU to the BSWM and the remaining 10% shall be transferred after the project is satisfactorily completed and has been certified by the BSWM and DA RFU I Inspection Team;

WHEREAS, the said MOA stipulates also that the LGU Narvacan shall submit to BSWM audited Statement of Liquidation (SOL) and Physical Accomplishment Report (PAR) of completed project within 30 calendar days from reported project completion;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the Municipal Mayor Edgardo D. Zaragoza to enter into a memorandum of agreement with the Bureau of Soils and Water Management (BSWM) and the Department of Agriculture Regional Filed Unit I (DA RFU I) for the purpose specified herein;

RESOLVED FURTHER that copies of this Resolution be forwarded to the BSWM, represented by its Executive Director, **DR. SILVINO Q. TEJADA**, and to the DA RFU I, represented by its Regional Executive Director **ATTY. CIPRIANO G. SANTIAGO**, to manifest adherence of the Municipality of Narvacan, Ilocos Sur to the Memorandum of Agreement (MOA).






