RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR EDGARDO D. ZARAGOZA TO ENTER INTO AN AGREEMENT OF COOPERATION WITH THE CENTRAL ILOCOS SUR DISTRICT HOSPITAL (CISDH) FOR THE PURPOSE SPECIFIED HEREIN

WHEREAS, RA 7160 known as the Local Government Code mandates for the devolution of the delivery of health services as one of the basic functions and responsibilities of Local Government Units (LGUs);

WHEREAS, the Health Covenant by the League of Provinces between the Secretary of Health and the Department of Interior and Local Government articulates their commitment for the implementation of the District Health System;

WHEREAS, a consultation/dialogue was made between Dr. Pablo R. Quedado, Officer-In-Charge of the Central Ilocos Sur District Hospital (CISDH) and the Municipal Mayors and Municipal Health Officers of the CISDH catchments to discuss issues, concerns and possible solutions to upgrade /improve the services of the hospital;

WHEREAS, this Resolution authorizes Mayor Edgardo D. Zaragoza to extend financial assistance in the amount of Fifty Thousand Pesos (P 50,000.00) to CISDH and to enter into an Agreement of Cooperation which has the general objective of ensuring and strengthening collaborative linkages between CISDH and its catchment municipalities through the generation, mobilization and allocation of essential resources for sustainable hospital and health services to attain the Millennium Development Goals (MDG) and National Objectives for Health;

WHEREAS, the Agreement of Cooperation stipulates also that the contribution from the catchment municipalities shall be deposited as TRUST FUND by the CISDH to be disbursed primarily for the procurement of drugs and medicines subject to government accounting and auditing procedures;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the Municipal Mayor Edgardo D. Zaragoza to enter into a an Agreement of Cooperation with the Central Ilocos Sur District Hospital (CISDH) for the purpose specified herein;

RESOLVED FURTHER that copies of this Resolution be forwarded to the Central Ilocos Sur District Hospital (CISDH), represented by its Officer-In-Charge, **DR. PABLO R. QUEDADO**, and to all parties concerned to manifest adherence of the Municipality of Narvacan, Ilocos Sur to the Agreement of Cooperation.
