**RESOLUTION GRADUALLY PHASING OUT THE LARGE SCALE PIGGERY PROJECT
OF MRS. FELICIDAD C. SABALBURO LOCATED AT BRGY. SULVEC,
THIS MUNICIPALITY**

WHEREAS, the Barangay Council of Brgy. Sulvec, Narvacan, Ilocos Sur had long passed and approved a resolution endorsing the petition complaint of the residents of Barangay Sulvec against the Sabalbuero piggery;

WHEREAS, the Sangguniang Bayan and employees of the Municipal Agriculture Office inspected the said piggery last February 9, 2009, and found out that it has violated the law;


WHEREAS, the Members of the Sangguniang Bayan of Narvacan, after careful deliberation, decided for the gradual phase out of the large scale piggery of Mrs. Felicidad C. Sabalbuero due to the following: **a)** the piggery has exceeded 250 heads, a violation of the Environmental Compliance Certificate; **b)** the disposal of solid wastes and wastewater was unsanitary; **c)** the piggery was too odorous causing health problems to residents and environmental degradation; **d)** the piggery farm is operating without Barangay Clearance and Mayor's Business Permit; and **e)** the dead pigs are being buried within the area;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to gradually phase out the large scale piggery of Mrs. Felicidad C. Sabalbuero by reducing the number of her pigs to 250 heads until December this year and by phasing out her piggery within two years thereafter;


