**RESOLUTION APPROVING THE ADDENDUM TO THE AMENDED CONTRACT OF  
LEASE BY AND BETWEEN THE MUNICIPALITY OF NARVACAN  
AND MAGICLUB INCORPORATED**

**WHEREAS**, Resolution No. 07-42, Series of 2007 requires all stallholders of the Narvacan Commercial Complex (Public Market II) to enter into a written contract with the Municipality of Narvacan;

**WHEREAS**, Magiclub Incorporated, represented by its General Manager **CELIA C. LIM** has been awarded the right to occupy stalls with a total area of 860 square meters of the Narvacan Commercial Complex (Public Market II), subject to terms and conditions under the Amended Contract of Lease;

**WHEREAS**, the Market Committee has decided to make an addendum to the Amended Contract of Lease;

**WHEREAS**, the addendum to the Amended Contract of Lease requires the Magiclub Incorporated to pay in addition to the rental, the Common Use of Services and Areas (CUSA) at the rate of Ten Pesos per square meter (P 10.00 / sq.m.);

**NOW THEREFORE**, on regular session duly assembled and on motion duly seconded, the Sangguniang Bayan of Narvacan **RESOLVED AS IT IS HEREBY RESOLVED** to approve the addendum to the Amended Contract of Lease by and between the Municipality of Narvacan and Magiclub Incorporated;


