## RESOLUTION NO. 22 Series of 2009

## RESOLUTION IMMEDIATELY CLOSING THE LARGE SCALE PIGGERY OWNED BY MRS. FELICIDAD SABALBURO OF BRGY. SULVEC, NARVACAN

**WHEREAS**, the Barangay Council of Brgy. Sulvec, Narvacan, had long passed and approved a resolution endorsing the petition complaint of the residents of Barangay Sulvec against the Sabalburo piggery located in the same barangay;

**WHEREAS,** the Municipal Health and Sanitation Monitoring Team inspected the said piggery on February 9, 2009 and found out that it has violated the law;

WHEREAS, the members of the Sangguniang Bayan of Narvacan, after careful deliberations on the findings and recommendations of the members of the Municipal Health and Sanitation Monitoring Team, decided for the immediate closure of the piggery of Mrs. Felicidad Sabalburo having violated environmental and zoning ordinances, to wit: 1) the piggery farm has no zoning clearance; 2) the piggery farm has no building permit; 3) the piggery farm defied the 500-meter distance from the national highway and 1,000-meter distance from build-ups; 4) the piggery farm has no Barangay Clearance, Mayor's Business Permit and Sanitary Permit; 5) the piggery farm was too odorous causing health problems to the residents; 6) that the disposal of solid wastes and waste water was unsanitary for they were disposed along the shorelines; and 7) that dead pigs are being buried within the area;

**WHEREAS,** the Municipal Health and Sanitation Monitoring Team went to the piggery site for re-inspection on June 24, 2009 but Mrs. Felicidad Sabalburo refused to let the authorities enter the premises of the piggery;

**NOW THEREFORE,** on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to immediately close the large scale piggery owned by Mrs. Felicidad Sabalburo of Brgy. Sulvec, Narvacan;

**RESOLVED FURTHER** that copies of this Resolution be forwarded to Mrs. Felicidad Sabalburo; to the Brgy. Council of Sulvec, Narvacan; to the Local Philippine National Police; and to the Department of Environment and Natural Resources — Environmental Management Bureau, San Fernando City, La Union for their information and reference.
