RESOLUTION EARNESTLY REQUESTING THE HONORABLE NASSER C. PANGANDAMAN, SECRETARY, DEPARTMENT OF AGRARIAN REFORM, TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF LUNGOG-CAMARAO BRIDGE THIS MUNICIPALITY


