RESOLUTION EARNESTLY REQUESTING THE HONORABLE NASSER C. PANGANDAMAN, SECRETARY, DEPARTMENT OF AGRARIAN REFORM, TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF CODOOG BRIDGE THIS MUNICIPALITY

Pangandaman**, Secretary, Department of Agrarian Reform to allocate funds for the construction of Codoog Bridge this municipality;


