**RESOLUTION ALLOWING THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT – FIELD OFFICE I TO CONDUCT THE HOUSEHOLD ASSESSMENT IN CONNECTION WITH THE IMPLEMENTATION OF THE NATIONAL HOUSEHOLD TARGETING SYSTEM FOR POVERTY REDUCTION (NHTS-PR) PROJECT**

**WHEREAS**, the NHTS-PR is a data management system that identifies who and where the poor are in the country;

**WHEREAS**, the system makes available to the public a database of poor households as a reference in identifying beneficiaries of social protection programs;

**WHEREAS**, the NHTS-PR is conceptualized to avoid leakage (of non poor being included) and exclusion (of poor being excluded) of social protection services;

**WHEREAS**, the NHTS-PR is a project of the National Government funded under the General Appropriations Act and the Department of Budget and Management has already approved a P 1 B budget for its nationwide implementation for the Fiscal Year 2009;

**WHEREAS**, a method of Proxy Means Test, which uses a paper and pencil approach for its data gathering, is administered in ranking and classifying the households after assessment;

**WHEREAS**, the Municipality of Narvacan is a target area of the NHTS-PR Project;

**WHEREAS**, household enumerators and area supervisors will be hired in the municipality and the DSWD will be funding their salaries/wages;

**WHEREAS**, household assessment in the area are only conducted to the identified pockets of poverty;

**WHEREAS**, identified pockets of poverty will be submitted to the Field Office which is an initial data obtained from the Municipal Social Development Officer and the Municipal Planning and Development Coordinator as a basis for hiring of staff for the municipality;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to allow the DSWD – FO I to conduct the Household Assessment in connection with the implementation of the National Household Targeting System for Poverty Reduction Project.


