RESOLUTION EARNESTLY REQUESTING HER EXCELLENCY GLORIA MACAPAGAL ARROYO, PRESIDENT, REPUBLIC OF THE PHILIPPINES, FOR HER FINANCIAL ASSISTANCE IN THE AMOUNT OF TWENTY MILLION PESOS (P 20,000,000.00) FOR THE CONSTRUCTION/REHABILITATION OF TUPAC BRIDGE IN BARANGAY CODOOG THIS MUNICIPALITY

WHEREAS, the Municipal Administration has placed on top of its development agenda the construction/rehabilitation of Tupac Bridge in Barangay Codoog this municipality;

WHEREAS, this goal, however, is constrained by financial limitation as the Municipal Administration depends on financial assistance from the national government that is ever supportive of our development efforts;

WHEREAS, the Municipal Administration urgently needs development funds to meet the urgency of the said project for almost every year both abutments are eroded by flood coupled with wear and tear making the bridge impassable and delaying transportation;

WHEREAS, when this happens, farmers, residents and traders experience severe hardships by manual handling in transferring their products/goods to the market;

WHEREAS, the construction/rehabilitation of Tupac Bridge will eventually reduce transportation expenses, travel time and promote intertrade relations with other communities thereby enhancing economic growth and development to the whole municipality;

WHEREAS, the Sangguniang Bayan of Narvacan, Ilocos Sur always trusts in the sincere concern of **Her Excellency Gloria Macapagal Arroyo** in sharing allocation to finance vital countryside infrastructure programs;

WHEREAS, the Municipal Administration has identified the construction/rehabilitation of Tupac Bridge in Barangay Codoog that needs the amount of Twenty Million Pesos (P 20,000,000.00) to bankroll this program;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to earnestly request **Her Excellency Gloria Macapagal Arroyo**, President, Republic of the Philippines, for her financial assistance in the amount of Twenty Million Pesos (P 20,000,000.00) for the construction/rehabilitation of Tupac Bridge in Barangay Codoog this municipality;
