Salary Grade: Twenty Two (22)

Salary /Annum: Php 483,972.00

APPROPRIATION ORDINANCE NO. 8 SERIES OF 2016

AN ORDINANCE AUTHORIZING THE ANNUAL BUDGET OF NARVACAN FOR FISCAL YEAR 2017 IN THE AMOUNT OF ONE HUNDRED SEVENTY TWO MILLION SIX HUNDERED SEVENTY NINE THOUSAND AND FOUR HUNDERED NINETEEN PESOS (P172,679,419.00) WITH AN UNAPPROPRIATED AMOUNT OF FORTY EIGHT THOUSAND AND TWENTY NINE PESOS (P48,092.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE LOCAL GOVERNMENT FOR FISCAL YEAR 2017, AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE

Be it ordained in Regular Session assembled:

SECTION 1. The Annual Budget of the Local Government Unit of Narvacan for Fiscal Year 2017 in the amount of ONE HUNDRED SEVENTY TWO MILLION SIX HUNDERED SEVENTY NINE THOUSAND AND FOUR HUNDERED NINETEEN PESOS (P172,679,419.00) WITH AN UNAPPROPRIATED AMOUNT OF FORTY EIGHT THOUSAND AND TWENTY NINE PESOS (P48,092.00) covering the various expenditures for the operation of the Municipal Government for the year 2017 is hereby approved.

- 2. Annual Operating Budget of Local Economic Enterprise.

SECTION 5. Separability Clause. If, for any reason, any Section or provision of this Appropriation Ordinance is disallowed in Budget Review or declared invalid by proper authorities, other sections or provisions hereof that are not affected thereby shall continue to be in full force and effect.

SECTION 6. Effectivity. The provisions of this Appropriation Ordinance shall take effect on January one, Two Thousand and Seventeen.
