RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ZURIEL S. ZARAGOZA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) REGION I FOR THE PERFORMANCE CHALLENGE FUND SUBSIDY

WHEREAS, the Department of Interior and Local Government (DILG) declared LGU Narvacan, Ilocos Sur as an awardee of the Seal of Good Governance (SGLG) "Pagkilala sa Katapatan ng Pamahalaang Lokal", in recognition to the significant effort it has exerted to become eligible thereby meeting the challenges set forth by the program in the pursuit of excellence in terms of performance and delivery of services;

WHEREAS, the CY 2016 SGLG awardees are conferred to access the 2016 Performance Challenge Fund (PCF) in the amount of P3 Million per Municipality;

WHEREAS, the Municipality of Narvacan, being one of the recipients of the Performance Challenge Fund (PCF) signifies its interest to avail the incentive fund to realize development projects and wider economic venture in the municipality;

WHEREAS, this Resolution authorizes the Municipal Mayor Zuriel S. Zaragoza to enter into a Memorandum of Agreement with the Department of the Interior and Local Government (DILG) Region I which stipulates that the DILG shall facilitate the release of the PCF subsidy amounting to Three (3) Million Pesos (P 3,000,000.00);

WHEREAS, the said MOA stipulates also that the LGU- Narvacan shall submit the project completion report to the DILG Regional Office with the required attachments upon completion of the project;
