**A RESOLUTION DECLARING THE WHOLE TOWN OF NARVACAN, ILOCOS SUR UNDER A STATE OF CALAMITY DUE TO SUPER TYPHOON 'LAWIN'**

**WHEREAS**, the path of Storm Signal No. 4 Codenamed Typhoon 'Lawin' left in its wake the destruction of agricultural lands and rice crops, flood control seawalls, roads and bridges, commercial buildings and residential houses in this town;

**WHEREAS**, strong, violent and powerful winds coming from all directions battered the sleeping town of Narvacan thereby felling century old trees, blown away roofs of residential houses, commercial and school buildings;

**WHEREAS**, floodwaters displaced families in the coastal areas including residents in the low lying areas and near riverbanks compelling the NDRRMC (Narvacan Disaster Risk Reduction Management Council) as well as the BDRRMC (Barangay Disaster Risk Reduction Management Councils) with the help of the Philippine Army and Coast Guard to work overtime to rescue residents bringing them to the assigned evacuation centers though Storm Warnings were given a day before;

**WHEREAS**, reports from the Narvacan Agriculture Office shows hectares of agricultural lands and rice crops submerged in muddy floodwaters coming from damage silted/eroded ricelands including reports on drowned and missing animals;

**WHEREAS**, morning of October 20, 2016, monitoring made by the NDRRMC and BDRRMC showed partial result of the extent of devastation caused by Super typhoon 'Lawin', alerting Municipal Officials to be on hand to extend all the necessary emergency assistance needed to secure the safety of the Narvacaneos;

**NOW THEREFORE**, the Sangguniang Bayan, in a Special Session duly assembled, and on motion duly seconded, **RESOLVED AS IT IS HEREBY RESOLVED** to declare Narvacan, Ilocos Sur under a State of Calamity due to Typhoon 'Lawin'.

**RESOLVED FURTHER**, that a copy of this Resolution be forwarded to all concerned for their information and reference.
