ZARAGOZA, MUNICIPAL MAYOR, NARVACAN, ILOCOS SUR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE BUREAU OF FISHERIES AND AQUATIC RESOURCES REGIONAL FISHERIES OFFICE NO. 1 (BFAR-RFO 1) AND THE REGIONAL FISHERFOLK REPRESENTATIVE (RFR) FOR THE IMPLEMENTATION OF THE PRIORITY POVERTY REDUCTION PROJECTS UNDER THE BOTTOM UP BUDGETING (BUB) FOR CY 2015 IDENTIFIED AS THE PROVISION ON "GILL NET" WORTH Php 750,000.00

WHEREAS, the "BFAR-1" is one of the National Government Agencies (NGAs) identified as partner in the implementation of the Priority Poverty Reduction Projects under the Bottom-Up Budgeting (BuB) for CY 2015;

WHEREAS, "BFAR-1" was given fund allocation under the General Appropriations Act of 2015 for expenditure on approved poverty reduction projects of identified Local Government Units (LGUs) in support to their CY 2015 Local Poverty Reduction Plans;

WHEREAS, "LGU-Narvacan" has made the necessary representation with "BFAR-1" for and in behalf of its constituents for the **Provision of Gill Net** amounting to **Seven Hundred Fifty Thousand Pesos Only (Php 750,000.00)**;

WHEREAS, this project aims to enhance agricultural production, improve fishing productivity, augment family income geared towards uplifting the standard of living of fishermen in the locality;

WHEREAS, cognizant to the vital role of the Regional Fisherfolk Representative (RFR) as partner in fishery development, the DA Secretary issued Special Order No. 88 S., 2009, authorizing the "RFR" to assist in monitoring and validating the implementation of BFAR-1 programs and projects;

WHEREAS, "BFAR-1", "LGU-Narvacan" and "RFR" agreed to cooperate and jointly implement the above cited projects thru this Memorandum of Agreement;

WHEREAS, premises considered, the Sangguniang Bayan in session assembled and on motion duly seconded by the Body, **RESOLVED AS IT IS HEREBY RESOLVED** to authorize the **Honorable Zuriel S. Zaragoza**, to enter into a **Memorandum of**

Agreement with the Bureau of Fisheries and Aquatic Resources Regional Fisheries Office No. 1 (BFAR-RFO 1) represented by its Regional Director Nestor D. Domenden, and the Regional Fisherfolk Representative (RFR) represented by Mr. Dante Noces for the implementation of the Priority Poverty Reduction Projects under the Bottom-Up Budgeting (BUB) for CY 2015 identified as the Provision of "Gill Net" worth Php 750,000.00.
